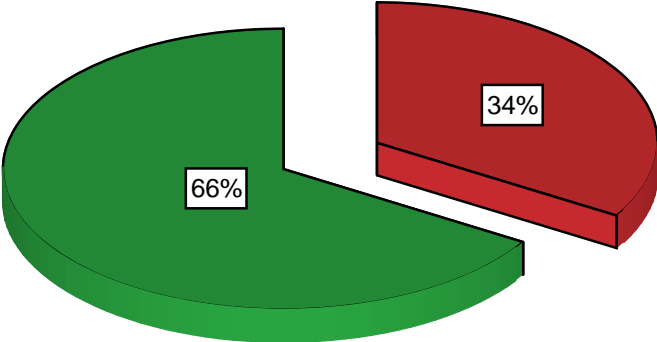

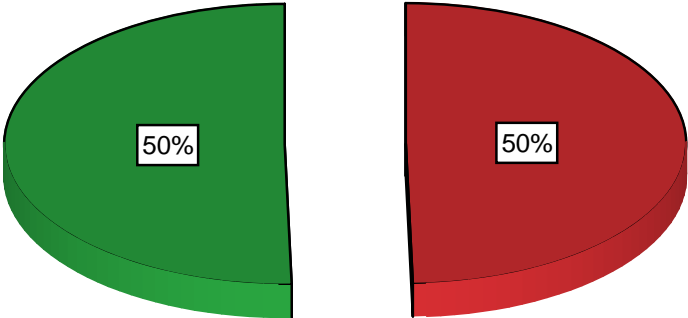

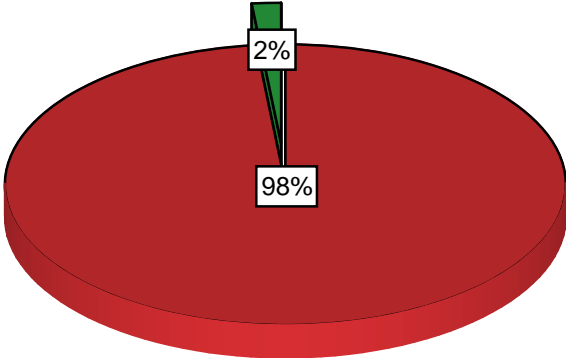

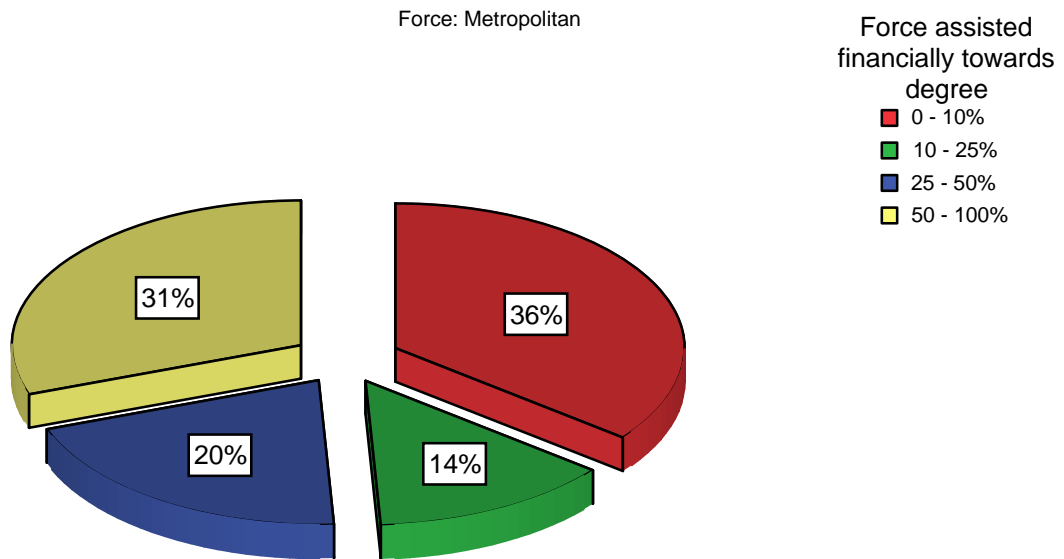

Amount of financial assistance from force towards degree

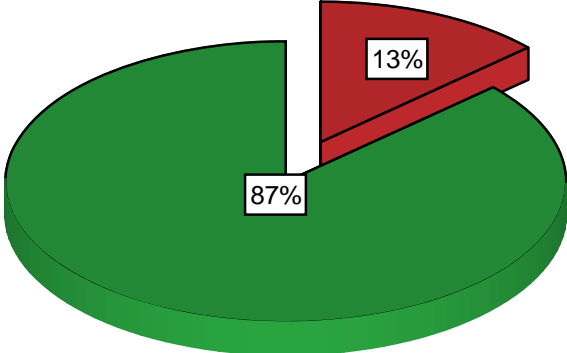

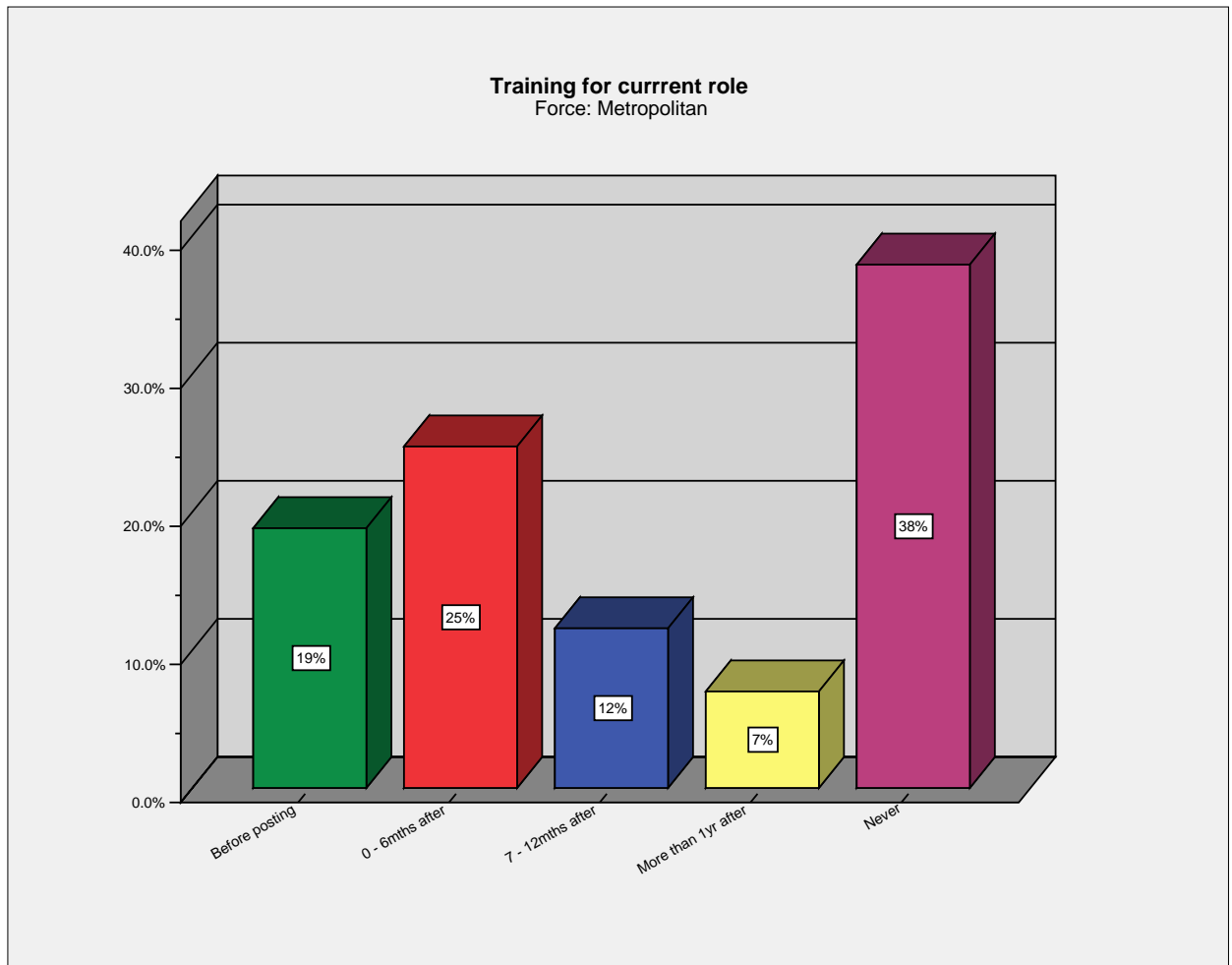

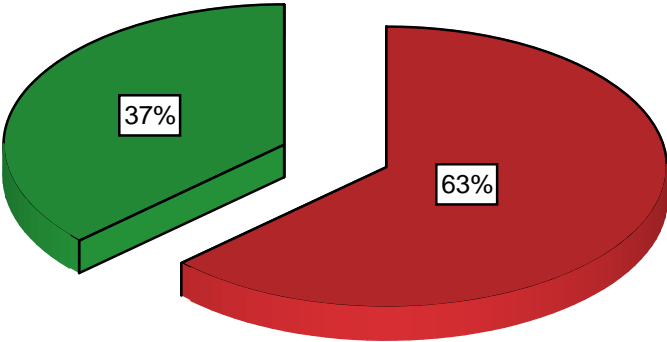

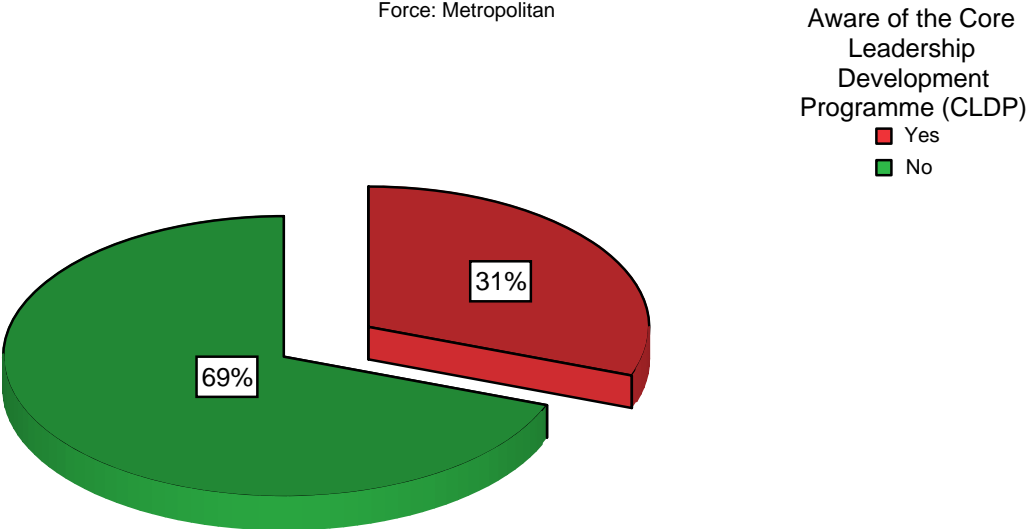

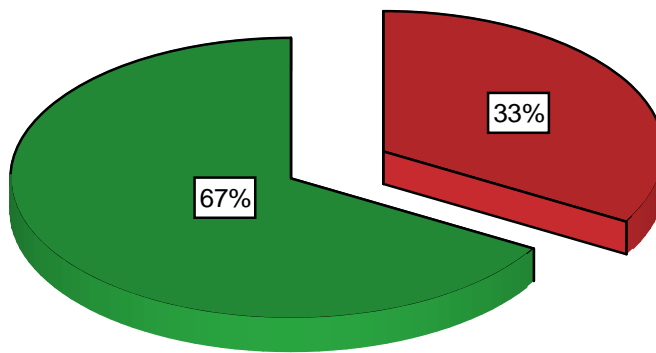

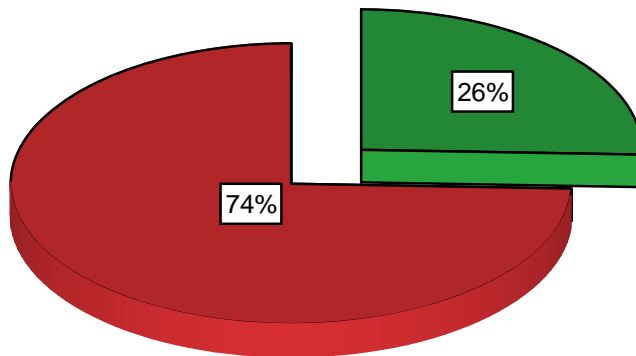

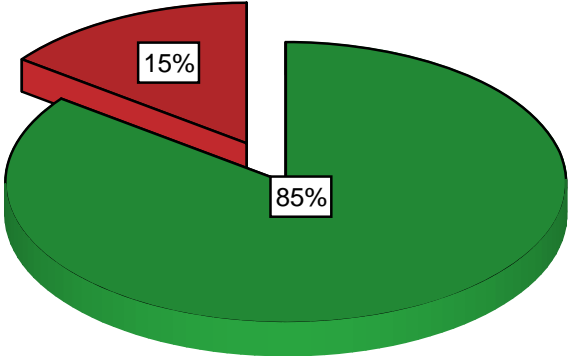

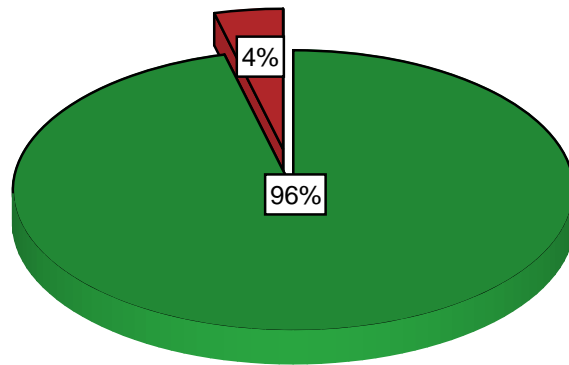

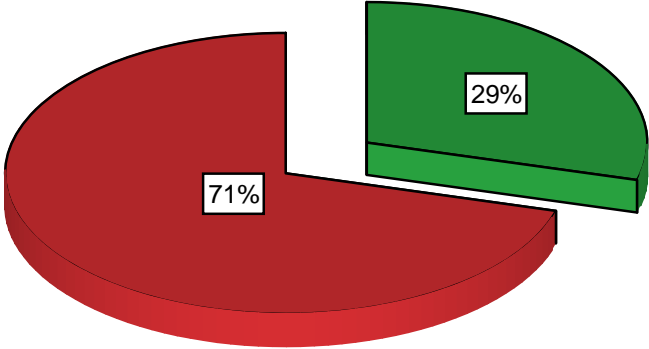

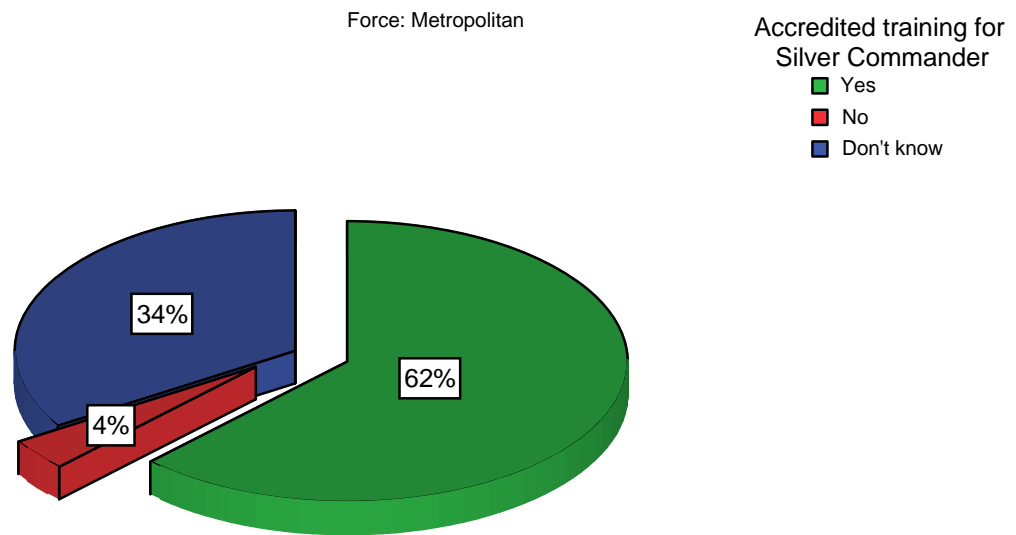

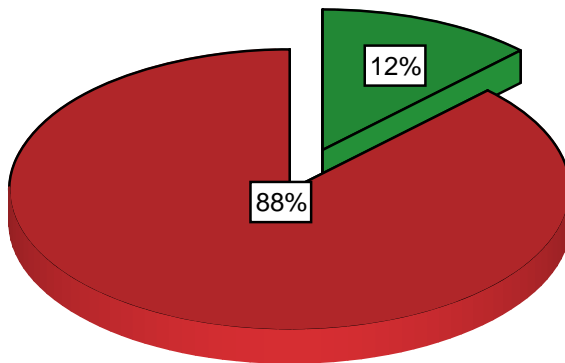

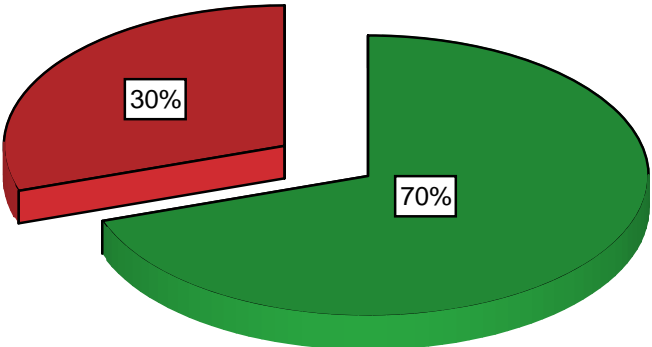

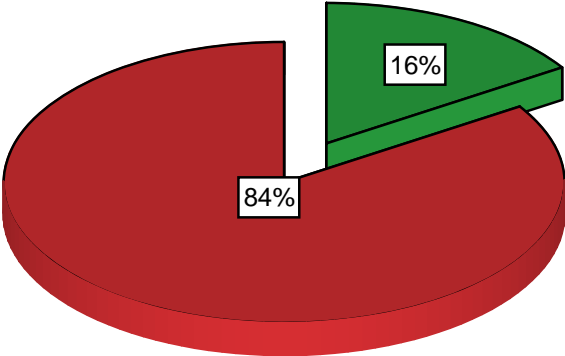

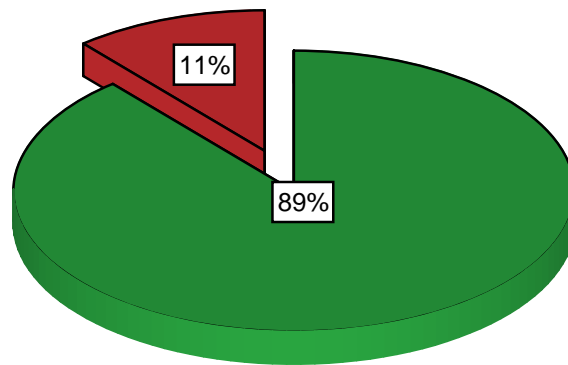

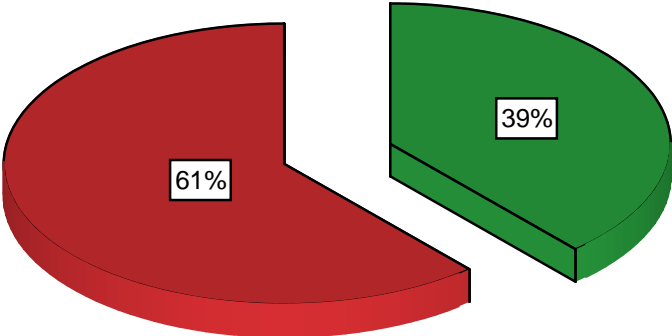


25a (ii) Do you have access to e-learning at home?

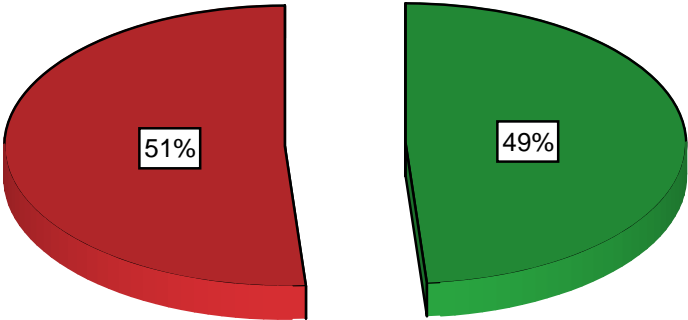

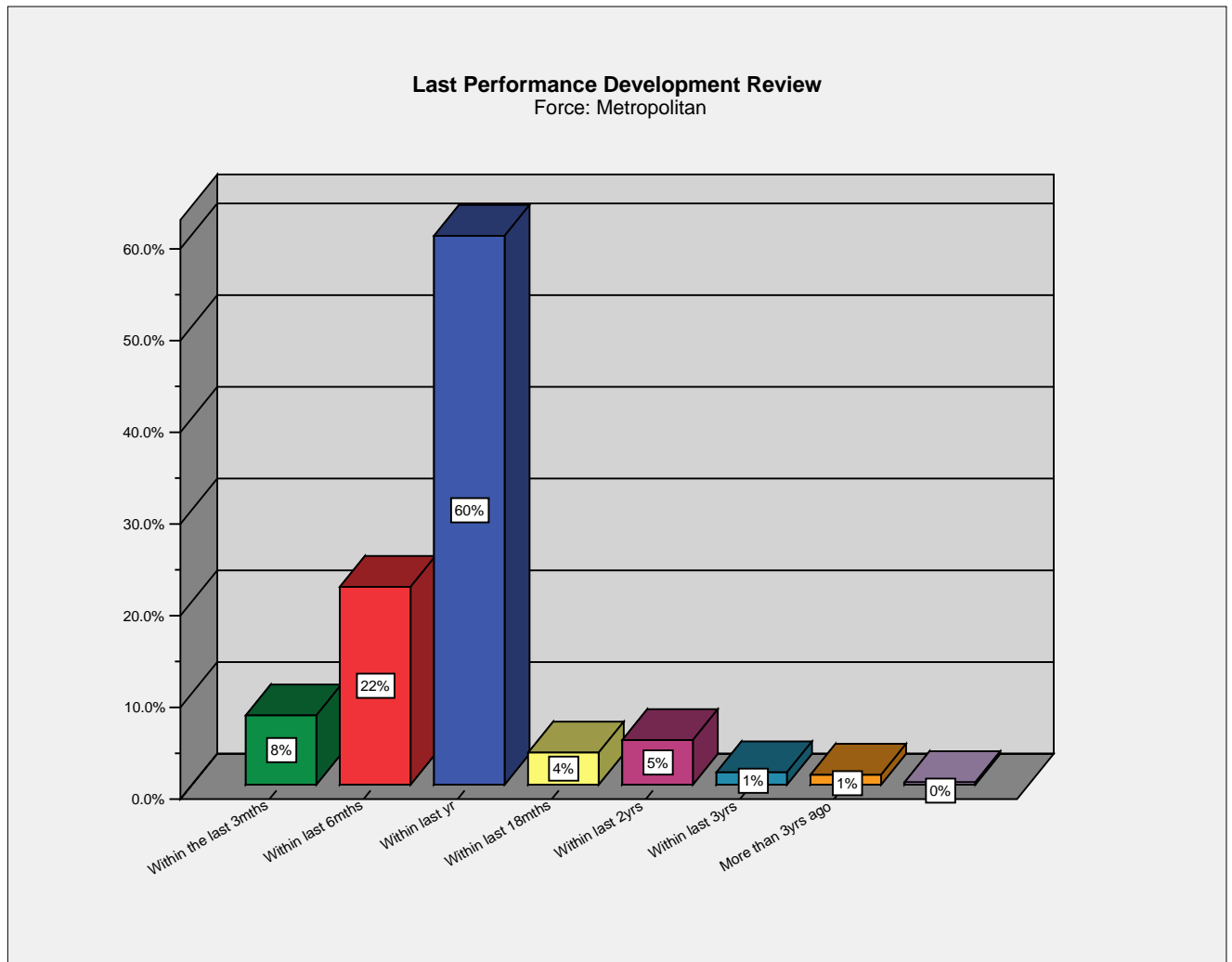

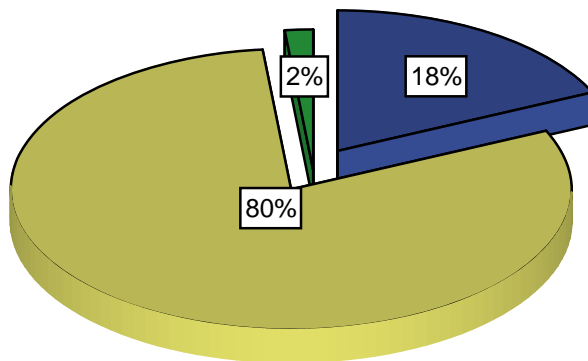

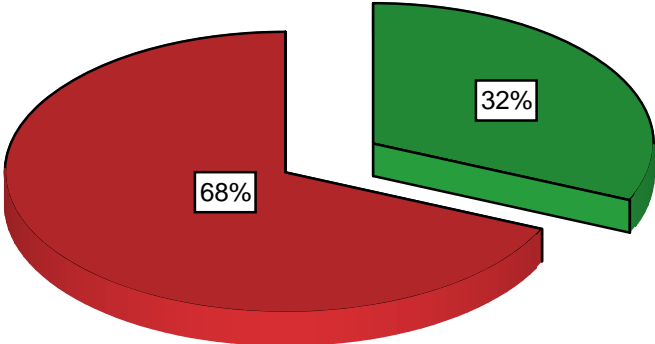

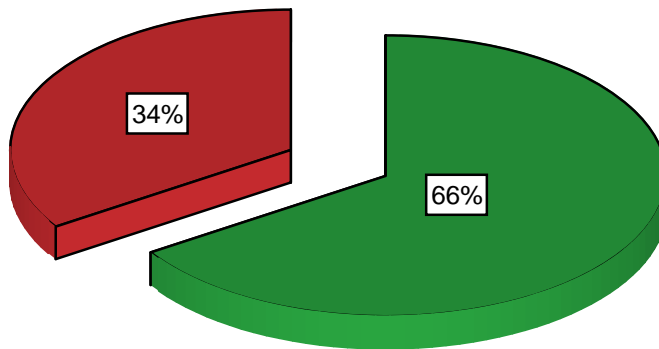

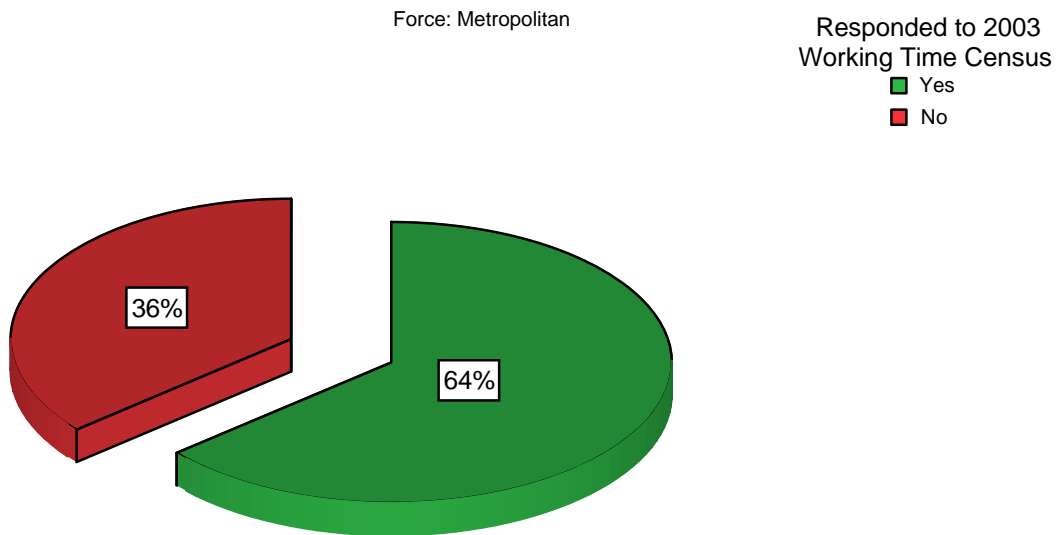

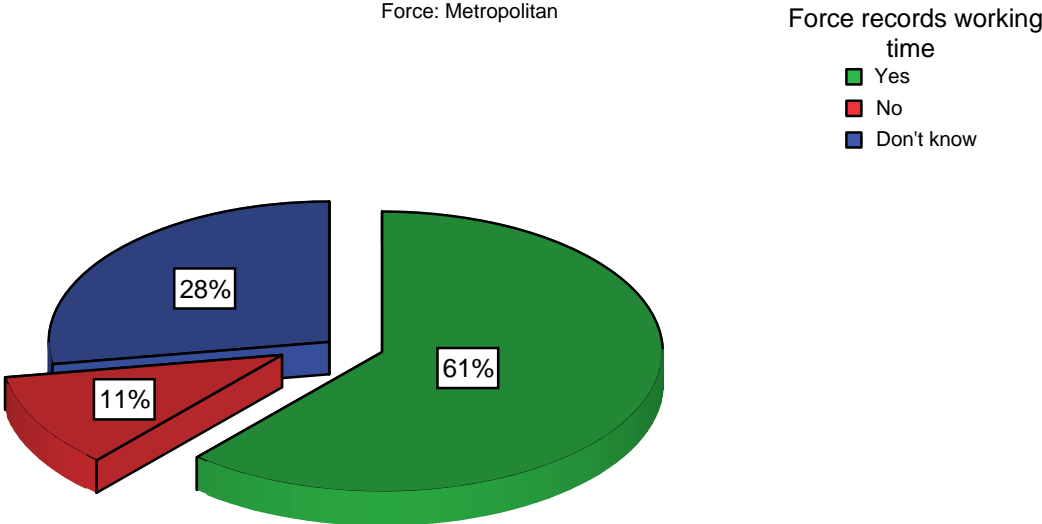
32. Did you respond to the 2003 National Inspectors' Working Time Census?

Responded to 2003 Working Time Census



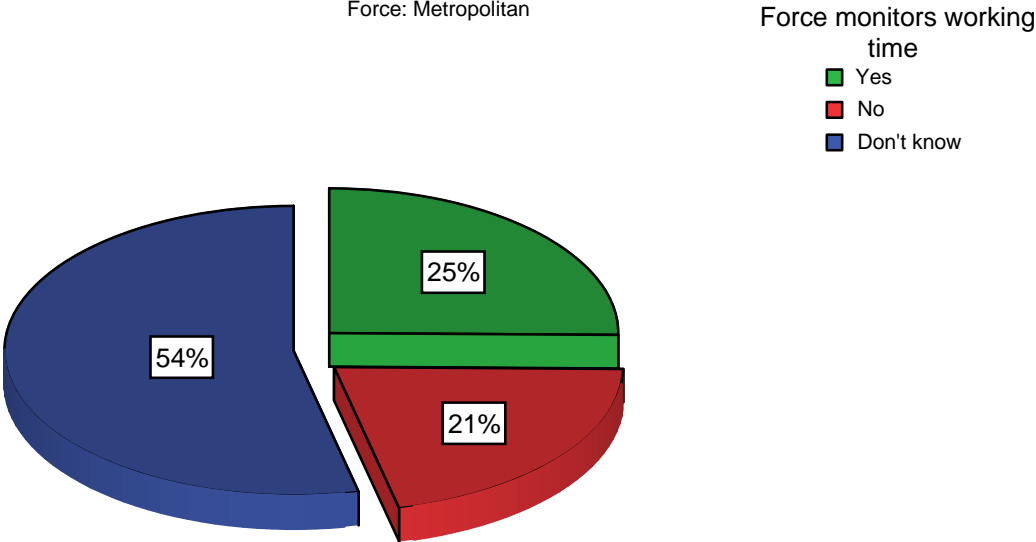
